



ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. **Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.**

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

1. How the LEA will, to the greatest extent practicable, implement prevention and mitigation policies in line with the most up-to-date guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning;
2. How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;
3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:

- a. Universal and correct wearing of [masks](#);
- b. Modifying facilities to allow for [physical distancing](#) (e.g., use of cohorts/podding);
- c. [Handwashing and respiratory etiquette](#);
- d. [Cleaning](#) and maintaining healthy facilities, including improving [ventilation](#);
- e. [Contact tracing](#) in combination with [isolation](#) and [quarantine](#), in collaboration with State and local health departments;
- f. [Diagnostic](#) and screening testing;
- g. Efforts to provide COVID-19 [vaccinations to school communities](#);
- h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
- i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021.* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.

*****Please be advised that the JYK Discovery charter School continues to research, update and adopt CDC and PA health Department guidelines based on the school population and assessed or identified school needs. Mask, testing quarantine and vaccination guidelines will be in compliance with approved government agencies and school needs.

1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

K-5 students will begin the school year with 100% of class in session. All students and teachers are required to wear mask or shields while in the classrooms and while in the hallway. Students will be required to wear mask in the hallways for the entire school day. Students will practice reasonable social distancing when traveling to and from other classes and when going to the bathroom and lunch.

Middle school will operate in person and will only participate in virtual learning if cases of COVID rise or in the case of extreme weather.

Bathrooms (will be cleaned and sanitized by sanitation team) hallways sanitized every twice a day.

Outdoor spaces will be used for outdoor recreation with masking guidelines in full effect for groups of 15- 20. Outside walks will be encouraged for each classroom when weather permits. Sanitizing stations continue to be strategically placed around the school so that students and staff will have an adequate opportunities to sanitize hands. Transportation is provided by the Philadelphia School District. JYK Discovery Charter School will defer to the guidelines set by the school district

Main office will require mask wearing by visitors and vendors. Climate control, Covid Preparedness Community Coordinator, Covid sanitation team, Custodial staff, Building operations oversight, Principal, CEO, SPED Director Social Worker, Counselor, will all continue to be trained and updated on the proper protocols for COVID 19 safety guidelines

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

Student will continue to be educated by qualified educators and certified teachers as well be provided with additional social services, as well absence monitoring that include home visits and parent contact via phone and email. All students will be

offered academic assistance after school in the area of Math and ELA Social work and counseling will continue to be incorporated into the roster for the new school year to ensure that all students are monitored and supported emotionally mentally and physically. Mental and emotional support will be given by the school counselor, and social worker. The COVID preparedness coordinator will interview and take referrals of students who have home needs such as food and clothing. The counselor will interview students to make sure that students physical and basic needs are met at home. All will continue to partner with the school nurse to ensure that the health and safety welfare of the student is met.

People who never develop symptoms (asymptomatic) or are not yet showing symptoms (pre-symptomatic) might not know that they are infected but can still spread COVID-19 to others. Masks also offer protection to the wearer as well as the persons they come in contact with.

more) of **laboratory-confirmed or probable COVID-19 patients.**

- Remote communications for the purposes of case investigation and contact tracing should be prioritized; in-person communication may be considered only after remote options have been exhausted.
- Testing is recommended for all [close contacts](#) of **confirmed or probable COVID-19 patients.**
- Those contacts who test positive (symptomatic or asymptomatic) should be [managed as a confirmed COVID-19 case.](#)
- Asymptomatic contacts testing negative should self-quarantine **for 5 days from their last exposure** (i.e., close encounter with confirmed or probable COVID-19 case)
- If testing is not available, **symptomatic close contacts** should self-isolate and be [managed as a probable COVID-19 case](#) according to CDC guidelines.
- **Asymptomatic close contacts** who are not tested should self-quarantine and be monitored for 14 days after their last exposure, with linkage to clinical care for those who develop symptoms.
- The best way to protect yourself and others is to [stay home for 14 days if you think you've been exposed to someone who has COVID-19.](#) Check your [local health department's website](#) for information about options in your area to possibly shorten this quarantine period.

We understand that according to the CDC guidelines, “the successful notification of exposure allows for an exchange of information with the person (contact) exposed to COVID-19 and offers an opportunity to answer questions and provide referrals for testing, medical evaluation and other necessary support services. The goals of this interaction are to inform the person that they may have been exposed to COVID-19, assess their medical condition and other risk factors, and gather information for continued monitoring and support. Developing trust and a warm, empathetic rapport, while maintaining a professional relationship, is key to providing effective support and collecting accurate

Individual student needs will continue to be addressed through IEPs, 504 Plans, individual medical plans, and other existing mechanisms as needed to ensure access to educational services for all eligible students.</p> <p>All plans and programs will continue to be designed to ensure the district is meeting IEP obligations to students with disabilities to the greatest extent possible. Continual monitoring of the health status and well-being of the students will continue to be done in coordination with the school nurses, the school physician, parents/guardians, private providers, and school counselors.</p> <p>Counselors, and school nurses will continue to communicate frequently with the families of students with significant medical risk factors to determine if additional precautions or unique measures are necessary.</p> <p>Individual Health Care Plans will be developed to protect and support staff, students, and their family members who are at higher risk for severe illness.
