# Financial Information for January 2025:

- Cash increased by \$531.3K compared to June 30, 2024.
- District Receivables increased by \$30.6K as compared to June 30, 2024.
- A/P & Accrued Expenses decreased by \$531.0K, while Accrued Salaries & Benefits decreased by \$338.4K, as compared to June 30, 2024.
- Equity (Restricted & Unrestricted Fund Balances) increased by \$677.0K as compared to June 30, 2024.
- Year to date (as of January 31, 2025), Revenues of \$7.61M have been recorded against Expenses of \$7.09M, resulting in a positive Change in Fund Balance (net income) of \$523.2K.
- All **short-term** Key Performance Indicators meet or exceed recommended benchmarks.

#### 1. Balance Sheet

- Cash sits at \$2,514,969 on January 31, 2025, the equivalent of 73.5 Days Cash on Hand (satisfying the 45-Day bond covenant), and School District Receivables currently stand at \$375,002.
- The school's Project Fund at US Bank (related to its Bond Issuance) remains at \$2.7M.
- Accounts Payable/Accrued Expense decreased to \$172,920 on January 31, 2025. In addition, the remaining balance owed to the SD of Philadelphia (\$751,145) has been satisfied. Accrued Salaries and Benefits decreased to \$560,622.
- Discovery CS's fiscal metrics are now compliant with 5/5 of the indicators monitored by the School District of Philadelphia (see KPI Report), and its Unrestricted Fund Balance has increased to \$6.2M.

# 2. Income Statement (Budget vs. Actual through January 31, 2025)

- Discovery CS has recorded Revenues of \$7,609,442 through January 31, 2025, which are over budget by \$852.6K. Most of the revenues recorded are District PPR (SD of Philadelphia and several neighboring districts). Also included in total revenue are \$1.40M of Federal, State, and Other Local Revenues.
- YTD Expenses of \$7,086,292 are over budget by \$495,906 through January 31, 2025. Most of this variance is related to Salaries (\$36.7K; mostly due to Summer Salaries), Professional & Technical Services (\$177.8K; mostly due to Special Education Services), Property Services (\$83.8K; mostly due to maintenance and repairs) and Supplies (\$171.6; mostly due to Instructional, Maintenance & Tech Supplies & Software).
- Through 7 months of FY25 activity, financial operations of the school culminated in a Net Operating Income (Change in Fund Balance) of \$523,150. In addition, the school is projected to meet its bond Debt Service Coverage Ratio requirement (1.66 based on February's projection, above the 1.10 requirement).

Unrestricted Cash: \$2,516,870, Bondholders require 5% Debt Service Coverage: 1.90, Bondholders require at least 1.1

Year-to-Date Revenue: \$7,546,776
